

Physicians and dentists who meet the following requirements can become members:

Diploma as a physician or dentist in the corresponding country.

Basic knowledge of medical laser applications (proof of participation in workshops, training courses, conferences, etc.)

Natural and legal persons can become patron members who support the pursuit of the association's purpose with an annual amount determined by the Board.

The written application for membership must be accompanied by the curriculum vitae, a copy of the doctor's diploma, and proof of basic knowledge in medical laser applications.

Each member undertakes to regularly attend training events and courses in the field of laser applications. Obtaining one or more "Fertigkeitsausweise für Laserbehandlungen der Haut und hautnahen Schleimhäute" is desired but is not a prerequisite for membership.

The SGML supports, promotes or organizes continuing education events and courses that are necessary for laser applications. Continuing education courses are recognized as those organized or recommended by the association itself as well as those organized by other institutions in Germany and abroad, which primarily serve the purpose of continuing education in the field of medical laser applications.

Members must attend the annual general meeting with training at least once within 3 calendar years. In case of non-compliance the membership expires.

Membership expires:

By resignation after written notification to the President or the Board. By deletion from the list of members by the Board, if the obligations towards the Association have not been fulfilled.

In the case of patron members, after one year has elapsed since payment of the last patronage fee.

The use or display of the membership certificate after expiry of membership is prohibited.

Declaration:

I hereby apply for membership in the Swiss Society for Medical Laser Applications SGML. I expressly accept the statutes of the association. The annual membership fee is currently CHF 200 and is payable annually at the end of each year. In case of admission during the year, the full annual fee is to be paid.
